Register by mailing in this completed form **with the waiver and fees** to Legacy Events Center, P.O. Box 618, Farmington, Utah 84025. Faxed entries are accepted only if a rider calls to verify we received the fax and gives full payment with a credit card when verifying the fax (fax to 801-451-4081). Registration and payment are due by noon the Thursday before the show, after noon, add a \$15 late fee per rider. Each rider must have their own completed and signed entry form **and waiver**. We are not responsible for entries not received in our office. We will not issue a refund or give a credit for any fees not used the day of the show. A rider cannot enter novice, intermediate and advanced classes in the same series. They must choose one "rank" based on their experience (not the horses) and stay in that rank for the series. Ribbons will be given at each class. One series end award will be given to the top rider in each age bracket at the last show in the series. You must attend and compete that day to receive any award. We do not hold awards. If the winner is not present, the award is forfeited. Western attire is preferred, but not mandatory. All riders are encouraged to wear helmets. Judges decisions are final. Points earned follow the rider, not the

This is a schooling show. We try to hire judges from the USU Extension Utah Open and 4-H Horse Show Judges' list. We instruct all judges to use NRHA / AQHA patterns.

Riders may enter judged classes up to two times. A rider who enters two times will be judged on each ride, but may only receive points for their single best ride, if it ranks in the top five of the class. Riders in judged classes are required to follow the assigned pattern to the best of their ability. Any riders who appear to intentionally not follow the pattern, will be asked to vacate the arena.

Time Only riders will be limited to 4 minutes and 30 seconds in the arena. Class 10 will be filled on a first come first serve basis.

Time slots will be filled starting at 5:30pm and work backwards. Time Only time slots must be paid in full with registration.

**LEGACY EVENTS CENTER
RELEASE, WAIVER OF LIABILITY, AND INDEMNITY AGREEMENT**

In consideration and as a condition of being permitted to enter upon, use, and remain upon the premises and facilities of the Legacy Events Center, owned and operated by Davis County, the undersigned, acknowledges, confirms, and agrees as follows:

For the purpose of this instrument:

- a. "Equestrian Activity or Event" means any horse related activity or event, or related activity or event conducted or occurring in or about the Legacy Events Center.
- b. "Related activity or event" includes, but is not limited to, driving, riding in or upon boarding or exiting a vehicle or trailer; moving, lifting, loading or unloading any equipment, people, gear, tack, animal, or other items; preparing any equipment, gear, trailer or vehicle, animal, or tack or practicing for engaging or participating in the activity or event.
- c. "Property damage" means damage, destruction, and or incapacitation to any physical property, real property or chattel.
- d. "Injury" means bodily or other personal injury or death.

1. The undersigned applies to Davis County for permission to enter upon, use, and remain upon the premises and facilities of the Legacy Events Center for the purpose of engaging or participating in an equestrian activity or event, including any related activities or events.
2. The undersigned acknowledges and agrees that equestrian (Horse) related activities are inherently dangerous and may result in death or serious injury to a participant. The inherent risks associated with Equestrian activities include, but are not limited to, (a) the propensity of the animal to behave in ways that may result in injury, harm, or death to persons on or around them; (b) the unpredictability of the animal's reaction to outside stimulation such as sounds, sudden movement, and unfamiliar objects, persons, or other animals; (c) collisions with other animals or objects; or (d) the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the animal or not acting within his or her ability. **DAVIS COUNTY IS NOT RESPONSIBLE FOR DEATH OR INJURY TO ANY PARTICIPANT IN AN EQUESTRIAN ACTIVITY CAUSED BY OR ARISING OUT OF THE INHERENT RISKS OF EQUESTRIAN ACTIVITIES.**
3. The undersigned is aware of, and agrees to fully comply with, all of the rules and regulations of the Legacy Events Center for the entry, use, and presence of the undersigned upon, on, or within the premises and facilities and engagement and participation in the said event or activity.
4. Prior to signing this release, waiver of liability, and indemnity agreement, the undersigned has had the opportunity to personally inspect the premises and facilities of the Legacy Events Center and to make inquiries and obtain all relevant and sufficient information and advice, including legal advice, about the nature, risks, and details of above-described activity, event, or related activities or events.
5. The undersigned acknowledges and confirms that the decision to engage in or participate in the said activity or event and to sign this release, waiver of liability, and indemnity agreement is a voluntary decision and act on the part of the undersigned.
6. The undersigned herewith agrees to release and waive any and every claim for liability which the undersigned may have against Davis County, the Davis County Fair Board, and any of the officers, employees, agents, representatives, and volunteers of Davis County or the Davis County Fair Board arising from any injury to the undersigned or any other person or damage to the property of the undersigned or any other person resulting from the entry, use, and presence of the undersigned on, upon, or within the premises or facilities of the Legacy Events Center or from the engagement or participation of the undersigned in said activity or event.
7. The undersigned herewith agree and promise Indemnify and hold Davis County, the Davis County Fair Board and its respective officers, agents, officials and employees, and volunteers harmless and release them for and from any liability, costs or expenses arising from any action, causes of action, claims for relief, demands, damages, expenses, costs, fees, or compensation, whether or not said actions, causes of action, claims for relief, demands, damages, costs, fees, expenses and/or compensations are known or unknown, are in law or equity, and without limitation, all claims of relief which can be set forth through a complaint or otherwise that may arise out of the acts or omissions, negligent or otherwise of the undersigned and/or his/her/their officers, agents, officials, members, employees, and volunteers, or any person or persons. In addition, User agrees to repair, solely at Users Cost, all damage to Town's facilities or equipment arising out or User's use or possession of said facilities or
